

The City of Leavenworth, Kansas Engineering Division Notice to Contractors Request for Bids City of Leavenworth Leavenworth Library Restroom Remodel Project Project No. 2019-905 the City of Leavenworth will receive bids for the proposed work at the office of the City Clerk 100 N 5th St in Leavenworth Kansas until 3 pm on April 3 2019 from all contractors for the construction of Project No. 2019-905 "Leavenworth Library Restroom Remodel Project" which time and place the proposals will be publicly opened and read aloud at City Hall 100 N 5th St Leavenworth KS. Bids shall be submitted in sealed envelopes addressed to the office of the City Clerk of Leavenworth, Kansas. Name of the bidder and "Project No. 2019-905" shall be clearly written on the envelope. Bids must be submitted on forms attached to and made a part of the contract documents. Bid and contract documents are on file in the Office of the City Clerk and are open for public inspection. Copies of the bid and contract documents may be obtained from Drexel Technologies, Inc, 10840 W. 86th Street, Lenexa, KS, 913-371-4430 at "NO CHARGE" to the contractor. All contractors desiring to be considered shall be required to comply with the City's Affirmative Action and Equal Employment Opportunities requirements. In order to verify compliance all firms considering this project and not in possession of a valid Certificate of Compliance issued by the City Manager's Office must complete and submit the City's Questionnaire on Personnel Practices for our review. Firms found in compliance with the City's AA/EEO requirements will be issued a Certificate of Compliance. A copy of the City's Questionnaire on Personnel Practices and instructions can be obtained in the Office of the City Manager by calling Charity Frey at 913-680-2604 or by email at cfrey@firstcity.org. To be considered, all firms MUST submit a copy of the "Affirmative Action Approval Letter" from the City Manager's Office and the Non-Collusion Affidavit with the bid. Contractor is required to comply with all provisions regarding Affirmative Action, Non-Collusion Affidavit, and other bidding conditions. There are no MBE/WBE requirements on this project and Davis Bacon Wages do not apply. All work will be funded by the City of Leavenworth and will be a tax exempt project. The approved contractor shall be required to procure insurance in amounts as required by the Office of the City Clerk a Statutory Bond a two (2) year Maintenance Bond and any required Contractor Licensing upon acceptance of the bid. The work embraced in this Contract shall begin within ten (10) days after written "Notice to Proceed" shall have been given to the Contractor by the City Engineer and carried on regularly and uninterruptedly thereafter (unless expressly directed otherwise and in writing by the City Engineer) with such force as to ensure full completion within Thirty (30) calendar days thereafter. If the Contractor shall fail to complete the work in the time specified the City shall have the right to deduct \$250.00 per day from the total compensation otherwise due Contractor as Liquidated Damages.
